- 3.2. Narajole Raj College will provide TCF with a list of eligible students interested in On-job-training or placements.
- 3.3. TCF will interview and select candidates based on their suitability and the company's requirements.
- 3.4. The duration of the On-job-training will be 30 days. Other relevant terms of the placements will be mutually agreed upon between Narajole Raj College and TCF for each placement opportunity.
- 3.5. Both parties will designate a liaison officer to facilitate communication and coordination.

4. Responsibilities:


- 4.1. Narajole Raj College Responsibilities:
