The terms & conditions of affiliation of the above courses :

01. Students will be admitted purely on merit basis and admission process should be completed as per the guidelines framed by the University.
02. At least one (01) whole-time contractual teacher and three (03) Guest-teachers, preferably retired teachers in the concerned subject are to be appointed before starting the course. The teachers should be qualified as per the UGC norms. Visiting Professors are also may be appointed for this purpose.
03. Text Books worth rupees one lac (Rs.1,00,000/-) only (at least) should be purchased in the relevant area as per the syllabus.
04. Equipments are to be procured as per syllabus.
05. All existing sanctioned posts of the concerned department are to be filled-up immediately.
06. The syllabus must be followed strictly, such that the whole portion of it is completed in time.
07. Internet accessing in the Departments are necessary.
08. The requirements of the Project Work in connection with the P.G. course must be met.
09. The college will have to submit an undertaking pertaining to implementation of Choice Based Credit System from this academic session.
10. The colleges will have to submit a compliance report to the University regarding fulfillment of the terms & conditions as above stipulated by the University in this regard.




